I AGREE that neither I, nor anyone acting on my behalf, will make a claim against, sue or otherwise maintain action of any kind against Dead Broke Farm, its owners, agents, instructors (Carla Carlough, Donald Ferguson and all other instructors), trail guides, and employees as a result of any injury, paralysis or death to me. This document shall serve as an assumption of risk and general release for all members of my family including my minor children and/or wards participating in any such activities.
